### Launch of The Scottish Green Energy Awards 2017

This year's Scottish Green Energy Awards were launched on July 24, and <u>nominations</u> for 10 categories are being accepted until September 8.

The event will be held in Edinburgh on November 30, and tickets are available here.

#### New fund launched for low-carbon start-ups

The Edinburgh Centre for Carbon Innovation fund, Climate-KIC Accelerator Stage 2, has opened for applications, giving fledgling climate entrepreneurs the chance to apply for dedicated support and funding of up to €20,000 to help get low-carbon start-ups investment ready. #### ETP Energy Industry Doctorate Programme

There is only one month to go until the proposal deadline for the <u>ETP Energy</u> <u>Industry Doctorate Programme 2017</u>. Six studentships are available to start before the end of March 2018. ETP will fund up to £30k towards the cost of each studentship, with the remaining costs split between the host universities and the industrial sponsors.

#### System Needs and Product Strategy

Scottish Renewables' response to <u>National Grids System Needs and Product</u> <u>Strategy consultation</u> welcomes National Grid's focus on creating new markets for system services, reinforces the need for a level playing field and acknowledges different investment needs and ongoing reform.

#### National Grid Workshop: De-rating Storage in the Capacity Market

National Grid's modelling team will be holding a workshop to discuss their proposal for a new methodology to de-rate energy storage participating in the Capacity Market. Proposals are part of the current <u>Capacity Market Consultation</u>.

Introduction to the Electricity Network: Charging and Regulation

Scottish Renewables is running a short CPD-accredited seminar, <u>Introduction to the</u> <u>electricity network: Charging and Regulation</u>, in Glasgow on 30 August, sponsored by Scottish and Southern Electricity Networks. This seminar will provide a valuable overview of the arrangements in place to govern the ownership, operation and regulation of the electricity network.

This <u>15-second survey</u> will help inform our work in this area.

BEIS/Ofgem publication: Upgrading our energy system

Ofgem and BEIS have launched a <u>Smart Systems and Flexibility Plan</u>, following the call for evidence on a <u>smart, flexible energy system</u>. The plan sets out a number of work areas which focus on removing barriers to smart technologies, smart homes and businesses and markets which work for flexibility.

The paper also underlines the importance of Ofgem's targeted charging review; the

Energy Network Associations <u>'Open Networks Project'</u> and Ofgem's forthcoming strategy for regulating the future energy system, expected in the autumn.

#### ENA Open Networks Project

The <u>ENA 'Open Networks' project</u> brings together all seven UK grid operators, academics, NGOs, government and Ofgem to lay the foundations of a smart energy grid in the UK. The project will focus on developing proposals around transmission/distribution processes; customer experience; DSO transition; charging and comms.

#### Scottish Renewables Responds to DNO Engagement Plans

Each year, Ofgem consults on the plans put forward by DNOs under the <u>Incentive</u> <u>on Connections Engagement</u> (ICE). ICE sets out a number of criteria on customer engagement which DNOs must follow, or face penalties.

DNOs have published reports on their engagement with connections customers over the past year as well as setting out their plans for the year ahead. <u>Scottish</u> <u>Renewables has responded to Ofgem for both the Scottish DNOs</u>.

The Scottish Government is consulting on <u>'Places, people and planning: Position</u> <u>Statement'</u> and its Strategic Environmental Assessment until 11 August.

#### SNH guidance: red kites

SNH has recently published <u>revised avoidance rates for red kite</u>. The document is intended for anyone involved with collision risk modelling for birds at onshore wind farms.

#### Media reaction: Fair Isle

Policy Manager Stephanie Clark <u>responded</u> to news that residents on Fair Isle are a step closer to having 24-hour power thanks to funding which will allow them to develop a new renewable energy system.

Scoping a Strategic Vision for the Uplands

SNH has published its <u>scoping report to the Scottish Government on developing a</u> <u>strategic vision for Scotland's uplands</u>.

The work has involved consultation with a wide range of stakeholders and the report summarises SNH's work and the views expressed, and makes a number of broad recommendations to inform the development of a strategic vision if Ministers decide to proceed.

Westminster Hall debate on renewable energy generation on the islands

A Westminster Hall debate, Renewable Energy Generation: Island Communities, was held on July 4. Scottish Renewables provided a briefing to MPs in advance of the debate.

The main outcomes are covered in <u>the Hansard report</u>: that Parliamentary Under Secretary of State at BEIS, Richard Harrington MP and officials are currently updating the evidence base to set a strike price for remote islands and want to ensure healthy competition to provide the best value for consumers.

## **Offshore Renewables**

#### Media reactions

Scottish Renewables Senior Policy Manager Lindsay Roberts responded to three media stories featuring offshore renewables in July:

- News that the Scottish Government has made a further investment of £1.5 million into the Carbon Trust's Offshore Wind Accelerator programme.
- <u>New research</u> into the economic benefits of the Beatrice Offshore Windfarm.
- News that the first of five floating offshore wind turbines has been towed into place at the Hywind development.

### Study on Lessons for Ocean Energy Development

The European Commission has published a report titled '<u>Study on Lessons for</u> <u>Ocean Energy Development</u>' which reviews failures, lessons learnt and good practices in wave and tidal technology.

The main conclusion is that the root causes and barriers to development are diverse and interrelated, which calls for an integrated solution which involves all stakeholders.
