Scottish Renewables sets out views on the future of regulation



Good Practice during Wind Farm Construction - latest version

The latest version of Good Practice during Wind Farm Construction has now been published. This version has received input from a range of stakeholders including Scottish Renewables members, Perth and Kinross Council planning staff, Historic Environment Scotland EIA staff, Forestry

Commission Scotland, SEPA and Marine Scotland freshwater staff.

New material includes a chapter on the Historic Environment; SEPA Construction site licenses; wind farm traffic on highways; more focussed information on Environmental Clerks of Works; less prescriptive information on habitat restoration and a general refresh of all chapters to bring them up to date with current good practice.

The meeting included landscape professionals, lawyers and Scottish Government, and aimed to work through the revised EIA position and its implications on the baseline for LVIA and ecological surveys.
