

Scottish Renewables Export Survey 2019

Summary:

- 27 respondents in total
- 15 respondent businesses are headquartered in Scotland
- 93.3% (14/15) Scottish businesses export out with UK
- 42.8% (6/14) of those who export out with the UK also employ staff out with UK
- 57.1% (8/14) of those who export are currently moving into new markets
- 28.6% (4/14) of those who export are currently considering moving into new markets
