Update to the Climate Change Plan published

The Scottish Government published its <u>Update to the Climate</u> <u>Change Plan: Securing a Green Recovery on a Path to Net</u> <u>Zero</u> on December 16. This document updates existing proposals and actions to bring them in line with achieving the 2045 net-zero target.

Following SR input at the drafting stage we are pleased to see that this document reaffirms The Scottish Government's support for renewable energy and consolidates its position as key to achieving net-zero. This position was reflected in our <u>statement to media</u>.

Meeting with Minister for Energy, Connectivity and the Islands

Claire Mack met with Energy Minister Paul Wheelhouse MSP to provide an industry update on the key issues affecting our sector.

The meeting explored the opportunities presented by the Strategic Marine Plan and how the Government can support the development of supply chains. The Minister also highlighted his support for Scottish Renewables' contributions to the Heat Networks Bill, and our key priorities for Stage 2 of this Bill were presented to the Minister.

Scottish Parliament elections

Following on from the publication of our manifesto for the 2021 Scottish Parliament election, <u>'A brighter future - priorities for</u> <u>the next Scottish Government'</u>, we have been meeting with key Parliamentarians and political party staff to discuss policy positions contained in the document.

We met with Mairi McAllan and Callum McCaig, Special Advisors to the First Minister of Scotland, who were supportive of our recommendations. A similar reception was received from Scottish Conservatives' Maurice Golden MSP, Shadow Cabinet Secretary for Economy, Fair Work and Culture, and Graham Simpson MSP, Shadow Cabinet Secretary for Transport, Infrastructure and Connectivity.

New transport sector statistics

We have updated the <u>statistics page</u> of our website with new data from the transport sector in Scotland.

Scottish Renewables will now be monitoring national statistics to track the number of electric vehicle charging points in Scotland, as renewables will play an important role in supplying the increased electricity demand from electric vehicles.

In 2019, Scotland had 1,226 public charging points on the <u>ChargePlace Scotland network</u>, up 524 from 2017.

Media reaction: Annual Energy Statement shows renewable power at 90.1%

The Scottish Government published its <u>Annual Energy</u> <u>Statement</u> on December 18, showing Scotland generated enough electricity from renewable sources last year to meet

the equivalent of 90.1% of the country's total electricity consumption.

<u>Responding</u>, Morag Watson said: "The figures announced by Scottish Government today demonstrate without a shadow of a doubt that renewable energy is now mainstream."

Media reaction: Energy White Paper

The UK Government published its <u>Energy White Paper</u>: <u>Powering our net zero future</u> on December 14.

<u>Responding</u>, Morag Watson said: "Scotland is already at the forefront of the energy transition, with the equivalent of 90 per cent of its electricity consumption generated by renewable energy resources. The next priority is to decarbonise heat and transport, and the White Paper provides the supporting context needed to ensure Scotland's abundant onshore and offshore wind resource is harnessed to address this."

The Sixth Carbon Budget - media reaction and blog

The Climate Change Committee (CCC) published <u>The Sixth</u> <u>Carbon Budget: The UK's Path to Net Zero</u> report on December 9, setting out for the first time the actions that the UK will need to take to achieve net-zero by 2050.

<u>Responding</u>, Morag Watson said: "We welcome the CCC's Sixth Carbon Budget, which contains advice to Government to move faster to reach net-zero and recognition that renewable technologies are key to delivering the cheap, low-carbon energy we need to achieve this."

Chief Planner letter: stakeholder update -December 2020

The Minister for Local Government, Housing and Planning, Kevin Stewart, and Chief Planner John McNairney have

written to stakeholders about progress and next steps for major planning workstreams including NPF4, Scottish Planning Policy, Scotland's Digital Strategy for Planning, Permitted Development Rights and implementation of the 2019 Planning Act.

The letter, which is available on The Scottish Government's <u>website</u>, also updates guidance on relaxing planning controls, where appropriate, during the pandemic.

Scottish Planning Policy - Finalised Amendments

The Scottish Government has published its <u>response</u>, with finalised amendments, to proposed changes to Scottish Planning Policy, which included removing the presumption in favour of sustainable development.

Following consultation, the Government has decided to retain but reword the presumption in favour of development to make it clear that the policy is to support *development that is sustainable development* rather than *development that contributes to sustainable development*.


SPP will now state that there is "a presumption in favour of sustainable development."

Tidal power consultation response

Scottish Renewables has submitted a <u>response</u> to the House of Commons' Environmental Audit Committee inquiry into Technological Innovations and Climate Change: Tidal Power.

It states that support for tidal stream technologies must be part of wider UK Government action to diversify the mix of lowcarbon generation that can support a green recovery and a just transition, while also helping open up routes to decarbonisation for other ocean nations.

Offshore wind research funding

A number of opportunities are currently open for project funding. The Supergen Programme has partnered with the Floating Wind Centre of Excellence, which is offering up to £50,000 additional match funding to the scheme. <u>The deadline</u> for expressions of interest is January <u>11</u>.

Separately, the ORJIP programme, managed by The Carbon Trust, is looking for project ideas on consenting risk for the

Scottish Marine Environmental Enhancement Fund seeks further partners

Scottish Renewables has been coordinating industry engagement with the new SMEEF model that is currently being developed for marine environment projects. A number of offshore wind members have generously contributed to support this initial stage, and a formal launch is planned for later in 2021.

Ofgem's Forward Work Programme 2021/22

Ofgem has launched its <u>Forward Work Programme for</u> <u>2021/22</u>, outlining its strategic goals for the year. These include enabling investment in low carbon infrastructure, delivering on full chain flexibility and ensuring energy system governance arrangements (including Ofgem's role) are fit for the future.


RIIO-2 Final Determinations

Following a <u>consultation</u> on the Draft Determinations earlier in the year, Ofgem published its <u>Final Determinations</u> for RIIO-2 on December 8.

Key decisions include an increase of £5 billion in baseline funding, at least £10 billion of funding available through the net-zero re-opener, and the introduction of greater flexibility into the uncertainty mechanisms to ensure timelines are better aligned to deliver net-zero.

BEIS has published a <u>summary</u> of stakeholder responses to its Reforming Energy Codes consultation from Autumn 2019. The Government is intending to publish a second consultation in 2021 following further policy development, taking into account the responses from the 2019 consultation.

Ofgem published its decision on the <u>RIIO-ED2 Sector Specific</u> <u>Methodology</u> on December 17. This is the framework for DNOs to build their business plans due to be submitted in 2021 for the 2023-28 price control period.

Arup has been engaged by SGN, Scottish Government, National Grid and the Energy Networks Association to evaluate the pathways for doing so. This work is investigating how gas networks can help support Scotland's 2030 and 2045 decarbonisation targets and examining the regulations, policies and investments that are needed to make this happen.

Heat in Buildings Strategy

Following a Parliamentary <u>question</u>, Paul Wheelhouse confirmed the Heat in Buildings Strategy will now be published in January 2021. The draft strategy will follow the update to the Climate Change Plan, setting out the Government's plan to reduce emissions from heating homes and buildings, and how it will remove poor energy efficiency as a driver of fuel poverty.

New renewable heat and energy efficiency incentive for homeowners

A new Scottish Government incentive for homeowners offers interest-free loans and cashback for the purchase of renewable systems and energy efficiency measures. The scheme will operate on a first-come, first-served basis until the end of financial year 2020/21.
