Last month we also <u>released new polling</u> which found almost half of 16-24 year olds questioned said they had taken a picture of a wind turbine, with three quarters of those saying they did so because they like the way it looked.

Planning Discussion Papers

Scottish Renewables has been working with some of our most experienced legal members to develop two discussion papers on how the commitments in the Scottish Government's NPF4 Position Statement can be met.

The first drafts of the papers on NPF4 and rebalancing the planning system and promoting nature-based solutions and prioritising carbon-reducing developments were circulated to members for initial comments. Second drafts are now in preparation in response to members' feedback.

The final papers will form the basis of submission to Cabinet Secretaries and Ministers by the CERG Planning sub-group in June.

DPEA Stakeholder Meeting

Stephanie Conesa participated in a DPEA Stakeholder Meeting to discuss updates from the DPEA, such as working through the pandemic and Annual Review Statistics, as well as current stakeholder issues. Stakeholders from Scotland Against Spin requested that developers make evidence for Public Inquiries and EIA Reports available on CDs to help those with poor broadband speed.

Stephanie will be meeting with the DPEA later this month to further discuss ways to improve how the DPEA circulates evidence through its automatic emailing system, casework and IT issues.



Update: SEPA Cyber-Attack

The latest update from SEPA on the cyber-attack on its IT systems can be found on the <u>SEPA website</u>. SEPA staff are currently engaging with the Energy Consents Unit (ECU) to start triaging and prioritising work on the accumulated backlog of casework. Guidance on how SEPA will triage the backlog is available on the agency's website.

Update: Carbon Calculator Tool

The ECU has confirmed that the <u>Carbon Calculator Tool</u> (CCT) is available and safe to use. The CCT is required to be

completed and submitted with a section 36 application under The Electricity Act 1989. If you submitted a section 36 application without using the CCT, please contact your case officer to discuss further.

Offshore conference captures industry ambition for ScotWind success

Hard work across the Scottish Renewables team delivered a bumper Offshore Wind Conference last month, with hundreds of delegates hearing from over 40 top industry speakers and engaging with exhibitors and networking opportunities over the two days.

<u>September</u>, which will focus even more sharply on the opportunities for SR members from Scotland's deeper waters.



Scottish Marine Energy Industry Group

Scottish Renewables hosted three industry-led subgroup meetings to discuss the future of wave and tidal in Scotland.

The first meeting focused the discussion on revenue support and financial streams. The second meeting outlined key barriers faced by project developers and how they could increase deployment. Finally, the third meeting addressed a possible deployment target, economic benefits, grid barriers/benefits and policy requirements.



Draft Heat in Buildings Strategy response submitted

Scottish Renewables submitted a response to The Scottish Government consultation on the **Draft Heat in Buildings** Strategy. The full strategy is expected to be published later this year.

We're expecting the publication of the UK Government's Heat and Building Strategy imminently and will inform members when this happens.





Heat Pump Sector Deal update

Scottish Renewables sits on the Expert Advisory Group (EAG) for the Heat Pump Sector Deal and we have consulted with members, via Policy Advisory Groups (PAGs), to feed into discussions. The group intends to publish an interim report in Spring 2021 and then recommendations to Scottish Ministers by the beginning of summer recess.

SR Policy Advisory Group on energy standards in buildings

Scottish Renewables sits on The Scottish Government's review group looking at the revision of the current building standards on energy. We recently held a PAG to feed in

member comments to this process. A consultation is expected soon.
