Last month saw our first meetings with new Scottish Government Ministers, including, of course, Michael Matheson, Cabinet Secretary for Net Zero, Energy and Transport.

With his new title mirroring a recommendation in Scottish Renewables' manifesto, Mr Matheson was keen to hear about the challenges facing our industry, particularly that of TNUoS charging - a topic which has been of particular focus for my team and I in recent months - and the planning system.

Scottish Government Ministerial meetings

As detailed in the introduction to this email, Claire Mack and Ben Walker met with Michael Matheson, Cabinet Secretary for Net Zero, Energy and Transport. SR updated the Cabinet Secretary on challenges facing our members and heard that Mr Matheson was particularly concerned about the impact of TNUoS on our ability to meet net-zero by 2045, and that he will focus where possible on tackling this. We also explored how to reform the planning system can help tackle the climate emergency; the Cabinet Secretary was keen to ensure that NPF4 supports our drive to net-zero, as well as increased renewables deployment. He also advised that he is keen to maximise the opportunities of renewable heat, and will be working closely with industry to deliver this.

Claire and Ben also met with Màiri McAllan, Minister for Environment, Biodiversity and Land Reform, as our first introductory meeting in this parliament. We discussed how to improve renewable energy engagement with environmental and marine stakeholders. The Minister also provided an update on the ScotWind Leasing Round, as well the Scottish Government's plans for the COP26 UN Climate Change Conference.

Holyrood Engagement

We have been continuing to deliver our post-election engagement to advance our priorities with new and returning MSPs. This month we have met with, among others, Liam Kerr, Scottish Conservative Shadow Cabinet Secretary for Net Zero, Energy and Transport; Brian Whittle, Scottish Conservative Shadow Minister for Environment, Biodiversity and Land Reform and new SNP MSPs Paul McLennan, Jackie Dunbar, Jenni Minto, Michelle Thomson and Audrey Nicoll.

We are continuing to influence parliamentary debates and worked with Sarah Boyack MSP in the recent debate on the [climate emergency](#). Scottish Renewables was [mentioned by Sarah](#) in relation to heat networks and renewable energy's contribution to the economy.

We have also re-established the Renewable Energy and Energy Efficiency Cross Party Group, known as SPREE, with new leadership for this parliamentary term.

Capacity Market auctions confirmed

UK Energy Minister Anne-Marie Trevelyan has [written a letter](#) to National Grid ESO to confirm that two Capacity Market auctions will be held in the auction window beginning on September 1, 2021.

The T-1 auction will be for delivery year 2022/23 and the T4 auction will be for delivery year 2025/26. Auction parameters will be set out in due course.


Hydrogen Strategy Now report

We have previously shared the survey that is the basis of this report with our Hydrogen Forum members.

In the published [report](#), key findings state that 78% believe the 5GW hydrogen production target set out in the PM's Ten Point Plan could be more ambitious, and that the lack of a Hydrogen Strategy has stalled or reduced valuable investments in the UK hydrogen sector.
