Last week The Scottish Government opened a consultation on its proposed update to the Onshore Wind Policy Statement.

The majority of the issues covered will be very familiar to onshore wind members but the consultation does touch on two important new issues which are the setting of a target between 8-12GW of additional onshore wind by 2030 and a proposal for a Sector Deal around this target.

Scottish Renewables will be responding to this consultation which will close on January 21 2022.

We are changing the way we work with members to gather their views to give members more opportunity to get involved. This new process is outlined here.

As we move into a new era of development of onshore wind in Scotland, we are also delighted to welcome our new Senior Policy Manager - Onshore Wind and Consenting, Mark Richardson. Mark will be leading our onshore brief and is looking forward to meeting our onshore members as we respond to this important consultation.

SR wins a Better Society Energy Award!

Scottish Renewables worked hard to place renewables at the heart of a green economic recovery at Holyrood and Westminster, and we're pleased to say that that work has now been recognised with a Better Society Energy Award.

Working with our members we produced research and media coverage to support our aims, then held more than 60 meetings with MPs and MSPs at which we set out our message, the outcomes of the new research which supported it, and the support our industry needed from both governments in a time of unprecedented change.

Outcomes include the creation of a £100 million Green Jobs Fund and a £25 million National Transition Training Fund, as well as the newly-launched Green Jobs Workforce Academy, which will allow people to access information, advice and skills needed to thrive in a net-zero economy.



COP26 Renewable Energy Roadshow

Our Year of COP Renewable Energy Roadshow reached its concluding stop last month in beautiful Pitlochry. We held a networking reception at Pitlochry Dam, where around 40 delegates heard speeches from John Swinney MSP, Deputy First Minister of Scotland, Gregor Alexander, SSE Group Finance Director and our own Claire Mack. We also held a public stand at Pitlochry Farmers Market where we met with local people to discuss what our industry brings to their area, how they can do more to tackle climate change and tell them about what's happening at COP26.

Media reaction: UK Government Autumn **Budget and Comprehensive Spending Review**

The UK Government has published its Autumn Budget and Comprehensive Spending Review which prioritises investing in stronger public services, building back greener, levelling up, driving business growth and helping working families with the cost of living.

Responding, Morag Watson, Director of Policy at Scottish Renewables, said: "Today's Autumn Budget and Comprehensive Spending review rightly prioritises the need to deliver a green recovery from the COVID-19 pandemic and achieving net-zero through the UK Government's ambition of 'building back greener'.

"The announcement of £380 million for the offshore wind sector to boost investment in this growing industry is a welcome move which will support Scotland's ambitions for the sector and deliver new green jobs and skills."

Holyrood engagement

As part of our ongoing MSP advocacy programme this month we met with Karen Adam MSP for Banffshire and Buchan Coast to discuss the rural benefits of renewable energy. We also organised the Renewable Energy and Energy Efficiency Cross Party Group meeting on Achieving Net-Zero Islands and Rural Communities, which was chaired by Jenni Minto MSP for Argyll and Bute.

Media reaction: UK Government Net Zero Strategy published

The UK Government has published its Net Zero Strategy which sets out policies and proposals for decarbonising all sectors of the UK economy to meet our net-zero target by 2050.

Responding, Morag Watson, Director of Policy at Scottish Renewables, said: "We welcome the announcement today from the UK Government of its Net Zero Strategy as a key step towards meeting our climate change targets of net-zero by 2045 in Scotland, and 2050 for the rest of the UK.

"The commitment to accelerate the deployment of low-cost renewable generation, such as wind and solar through the Contracts for Difference (CfD) scheme by undertaking a review of the frequency of the CfD auctions is crucial to ensuring all our electricity comes from low-carbon sources by 2035. Wind and solar are already the cheapest source of electricity and annual CfD auctions will enable industry to bring forward the volume of renewables net-zero requires at the lowest cost to consumers."

Draft NPF4 Out for Consultation

Following extensive advocacy and engagement by Scottish Renewables, The Scottish Government has laid the draft NPF4 before the Scottish Parliament.

This kickstarts a period of Parliamentary scrutiny and extensive public consultation, lasting up to 120 days, until March 31, 2022. The final NPF4 version is scheduled for approval and adoption prior to Summer Recess 2022.

Scottish Renewables will be responding to this consultation. As previously mentioned, we are changing the way we work with members to gather views and give members more opportunity to get involved. This new process is outlined here.

Media reaction: Onshore Wind Industry Prospectus launched

New research shows that a more ambitious onshore wind target for Scotland could produce £27.8 billion of economic activity while helping meet the country's net-zero target.

Responding, Morag Watson, Director of Policy of Scottish Renewables, said: "The Onshore Wind Industry Prospectus published today shows the enormous benefits of increasing our ambition for Scotland's outstanding wind resource and allowing onshore wind - one of the cheapest and most popular forms of energy generation – to take its rightful place at the heart of a net-zero energy mix."

The Climate Change Committee's Sixth Carbon Budget outlines that Scotland will need to deploy a further 12GW of onshore wind by 2030 and industry research shows that this will deliver 17,000 new jobs and £27.8bn GVA into our economy."

LOW-CARBON HEAT



Media reaction: Scottish Government Heat in **Buildings strategy published**

The Scottish Government published its Heat in Buildings Strategy setting out the actions it will take in the buildings sector to deliver on climate change commitments, support economic opportunities, and ensure a just transition, including helping address fuel poverty.

Responding, Morag Watson, Director of Policy of Scottish Renewables, said: "We welcome today's publication of The Scottish Government's Heat in Buildings Strategy which commits to eliminating emissions of greenhouse gases from heating Scotland's homes and buildings by 2045 through the use of low-carbon heating solutions powered by renewable energy."

Market mechanism for low-carbon heat consultation

This consultation was announced as part of the UK Heat and Buildings Strategy examining a market-based mechanism for low-carbon heat. This consultation seeks views on proposals to introduce a market-based mechanism to support the development of the UK market for low-carbon electric heat pumps. The government's intention is that the proposed obligation should apply throughout the UK.

Heat Pump Ready Programme

Published alongside the UK Government's Heat and Buildings Strategy, the Heat Pump Ready Programme will support the development of innovative solutions across the heat pump sector. Heat pumps are a key solution for decarbonising homes and will be critical for meeting the UK's commitment to achieve net zero by 2050. The programme is expected to launch in winter 2021.

Media reaction: Scottish Government renewable heat target update

The Scottish Government <u>published</u> an update on the progress toward meeting the target of 11% of non-electrical heat demand from renewable sources by 2020.

Responding, Helen Melone, Senior Policy Manager at Scottish Renewables, said: "We are disappointed to see the figures released today (6.4%) that show that Scotland has not made any progress on decarbonising the way it keeps warm and did not meet its 2020 target of 11% of heat to be delivered by renewables."



Heat Networks Policy Advisory Group

Scottish Renewables is going to reconvene the Heat Networks Policy Advisory Group in late November. The proposed date and time for this is Friday, November 26, 10-11:30am.

We have been informed that the draft Heat Networks Delivery Plan will have an extremely short consultation period, so this meeting will discuss the draft if it is out or make decisions on strategy.



Media reaction: UK Government Heat and **Buildings Strategy published**

The UK Government has today published the Heat and Buildings Strategy setting out plans to incentivise the installation of low-carbon heating systems and replace old boilers over the coming decade.

Responding, Helen Melone, Senior Policy Manager at Scottish Renewables, said: "We welcome the announcement today from the UK Government of its plan to drive down the cost of clean heat, with more than £3.9 billion of new funding to decarbonise heat and buildings. It's crucial that people and business across the UK are incentivised to move away from gas boilers and install clean heating systems."

District Heating Loan Fund

Energy Saving Trust manages the District Heating Loan Fund which is currently open for applications. This fund is designed to help address the financial and technical barriers to renewable powered district heating projects. Loans of up to £1 million plus are available as low interest unsecured loans with repayment terms of up to 15 years.

Consultation: Domestic Energy Performance Certificates (EPC) reform

Scottish Renewables submitted a response to this consultation which is setting out the changes to the Energy Performance Certificates (EPC) format leading on from proposals set out in the draft Heat in Buildings Strategy to reform the EPC framework.
