With the world's attention on Scotland with Glasgow hosting COP26 the United Nations Climate Change Conference last month, Scottish Renewables had an active programme of engagement throughout the two weeks in November.

On Energy Day at COP26 we released a new publication 'Beyond COP26 - next steps for Scotland's Clean Energy Revolution' which recommends five key actions for The Scottish Government to adopt to achieve a lasting legacy for COP26.

We also held a reception in Glasgow on Energy Day which brought together our members who are leading Scotland's energy transition, and Scottish parliamentarians including Richard Lochhead MSP, Minister for Just Transition, Employment and Fair Work, and Patrick Harvie MSP, Minister for Zero Carbon Building, Active Travel and Tenants Rights.



We also reaffirmed our call for the <u>reform of the damaging TNUoS transmission charging regime</u> as a legacy ask for Scotland's renewables industry for the UK Government from COP26, with Claire Mack appearing on BBC Good Morning Scotland and on STV News to discuss.

The SR Team was also busy supporting member and Scottish Government events covering energy transition, hydrogen, lowcarbon heat, marine energy, networks, offshore wind, onshore wind, pumped storage hydro, solar and supply chain.

# Draft National Planning Framework 4 Consultation

In addition to responding to The Scottish Government's NPF4 consultation, we will also be responding to the Scottish Parliament's call for views on the draft NPF4 which closes on January 10, 2022.

## **Remote Island Wind Roundtable Meeting**

We focused on the need to reform TNUoS drawn from <a href="https://our.new.our.response-to-the-Call for-Evidence-on TNUoS">our response-to-the-Call for-Evidence-on TNUoS</a> recently submitted to Ofgem.

William Black has indicated that The Scottish Government intends this to be the start of an ongoing series of meetings aimed at building its understanding of RIW issues and working to find solutions for them.

# Media reaction: UK Government announcement on tidal energy

The UK Government has <u>announced</u> it will invest £20 million per year in tidal stream electricity as part of its renewable energy auction scheme.

Responding, Morag Watson, Director of Policy at Scottish Renewables, said: "We are very pleased that the UK Government has recognised the pivotal moment that our marine renewables sector has reached. Ringfenced funding to get more projects in the water is essential and we hope to see further success for our Scottish tidal technology leaders as a result."

#### Sectoral Marine Plan call for evidence

Marine Scotland has called for further evidence to inform the Sectoral Marine Plan for Offshore Wind, as part of the iterative review process in the Plan. Early discussion with members has suggested that any new evidence that members hold is best submitted on an individual basis, but we will consider whether there is a need for an industry-wide representation at the next SOWEC Barriers to Deployment meeting in January. The deadline is February 28, 2021.

## BEIS developing new floating wind fund

As part of the UK Government's spending review it was announced that a further £160m has been allocated to support floating offshore wind. SR is engaging with BEIS and industry colleagues to provide input as this opportunity develops.

## **Contracts for Difference Explainer**

To support members who are less familiar with the Contracts for Difference (CfD) mechanism, Scottish Renewables commissioned BVG Associates to produce an <a href="Explainer of the CfD mechanism"><u>Explainer of the CfD mechanism</u></a> including analysis of possible outcomes of Allocation Round 4.

#### **Contracts for Difference**

#### **Round 4: Budget Recommendation**

Scottish Renewables wrote a <u>letter</u> to BEIS with recommendations for the final budget of the CfD Allocation Round 4. The key recommendations included the increase of the capacity cap for pot 1, a minima for marine renewables, and the suggestion of adjusting the budget for pot 3 if a limited proportion of offshore wind projects in the pipeline come forward due to price uncertainty caused by high TNUoS charges.

#### **Round 4: Final Parameters**

BEIS has released the <u>final parameters of the AR4</u>. Pot 1 includes a £10 million budget with capacity caps of 5GW in total and with maximum capacity limits of 3.5GW on both onshore wind and solar PV. Pot 2 includes a budget of £55 million with £24 and £20 million minimum for floating offshore wind and tidal stream respectively. Pot 3 for offshore wind includes a budget of £200 million.

#### Round 4: further changes to the CfD contract

BEIS has announced further changes to the CfD contract. The government confirmed its decision to make several additional amendments to the CfD Standard Terms and Conditions (the contract) for the CfD Allocation Round 4. One of the amendments confirmed that if Ofgem decides to remove BSUoS charges from generators, regardless of when this decision is taken, the strike prices of those successful projects liable to pay BSUoS charges would be adjusted downwards after contracts are awarded.

# Renewable energy industry calls for reform of the TNUoS transmission charging regime

We issued this press release which reaffirmed Scottish Renewables calls for the UK Government and Ofgem, the energy regulator, to work together in the spirit of COP26 to achieve a solution to the Transmission Network Use of System (TNUoS) charging regime, as government had previously committed to do in its recent energy white paper.

Claire Mack, Chief Executive of Scottish Renewables, said: "Scotland's renewable energy industry has a huge contribution to make because of the strength of resource that exists here but transmission charging rules which govern how the electricity network is paid for are restricting the development of major projects."

# Consultation on the proposal to take forward the reform of Distribution Use of System (DUoS) charges under a separate Significant **Code Review**

The meeting focused on discussion about descoping DUoS reform from the current Access and Forward-looking Charges Significant Code Review. The outcomes of this discussion helped us to shape our draft response, which was sent out for member's feedback on November 25.

## National Grid ESO Electricity Market Reform

National Grid ESO released the outcomes of the second phase of the Electricity Market Reform on November 18. The report identified three major challenges for markets to address on the road to net-zero. These include the need to invest at unprecedented scale and pace, the need to manage dramatic energy imbalances with flexible and firm technologies across both supply and demand, and the need to incentivise assets to locate and dispatch where they can minimise whole system cost.

# Publication of the Heat Pump Sector Deal **Expert Advisory Group - Final Report**

We were delighted to be part of this group and work on developing recommendations for Scottish Ministers on a potential Heat Pump Sector Deal in Scotland.

In order to scale up from approximately 3,000 heat pumps a year currently, to 200,000 per year towards the end of this decade requires significant actions to be taken, for example, increasing the funding available through loans and grants to support heat pump installation and provide multi-year certainty on the availability of this funding.

The Scottish Government is going to work towards responding to these recommendations within the Heat in Buildings Strategy Supply Chain Delivery Plan which is to be published next year.

# National Public Energy Agency - call for evidence

The Scottish Government has published a Call for Evidence on Scotland's National Public Energy Agency, alongside a Public Energy Company Outline Business Case. The closing date is February 8, 2022.

In the Heat in Buildings Strategy, it says that the National Public Energy Agency would be established "to accelerate the transformational change required in how we heat and use energy in homes and buildings".

We plan to hold a Policy Advisory Group in early January, proposed date and time Friday, January 7, 2022 at 11:00 -12:30.

# Non-Domestic Renewable Heat Incentive (NDRHI) potential extension - consultation

The UK Government is carrying out a short consultation on possible changes to the NDRHI scheme. As a result of challenges related to the COVID-19 pandemic, the Government is looking at providing an additional 12-month extension (from 31 March 2022 to 31 March 2023) for the NDRHI's remaining tariff guarantee and extension application deadlines for non-biomethane technologies.
