Dear member,

As you may already be aware, a new system of pricing for the electricity network poses a significant threat to our industry. SR has acted quickly to simplify Locational Marginal Pricing or 'Postcode Pricing' - for members, as well as to publicise the issue to a wider audience before it develops further.

This blog explains clearly how the new system would differ from TNUoS - already the subject of a review after action from SR and others - and why making these changes now would be bad for, among other things, net-zero.



We also worked with the Herald on Sunday to achieve frontpage coverage (detailed later in this email), with that article being the subject of a Parliamentary question by Emma Roddick MSP.

Local Government, Housing and Planning Committee Debate: NPF4

Scottish Renewables briefed MSPs ahead of a committee debate on NPF4 last month, with Dean Lockhart highlighting our concerns about the length of time taken for planning applications, which meant turbine technology became obsolete before being approved, while Mark Griffin quoted Scottish Renewables, saying the draft NPF4 did not support an expansion of renewable energy.

New Regulations on planning fees come into force

New regulations on Scottish planning fees came into force on April 1 which will see fees increase in most cases by between 25% and 50%. Visit The Scottish Government website, <u>Improving planning processes</u> for more information. The ePlanning Fee Calculator has been updated to reflect these changes in planning fees.

The Scottish Government and Energy Consents Unit launched a consultation on March 30 seeking views on proposed further changes to fees charged for applications under the Electricity Act 1989. SR will be responding to this consultation which closes on June 23. We welcome member comments on this consultation using this consultation questionnaire template. Contact Mark for more information.

New Regulations on Extending Coronavirus Modifications come into force

The following Scottish Statutory Instruments came into force on March 30:

- Town and Country Planning (Miscellaneous Temporary) Modifications) (Scotland) Regulations 2022
- The Planning (Scotland) Act 2019 (Commencement No. 6 and Transitional Provision) Amendment Regulations 2022

Details of the effect of the new provisions are described in the relevant policy note for each SSI, available through the above links (see 'More Resources'). Read SR's new legislation explainer, with thanks to Marcus Trinick QC, on our website.

Broadly, the two sets of regulations roll forward the current position with Coronavirus Modifications to Planning legislation (Duration of permission/consent and pre-application consultation) for a further six months up to September 30. Coronavirus modifications regarding environmental impact assessment reports remain in place.

Community Benefit and Ownership Models for Onshore Wind

Scottish Renewables, in collaboration with RenewableUK, RUK Cymru and RenewableNI, hosted an initial onshore wind developer workshop to discuss community benefits and ownership models bringing together stakeholders to establish initial views and feedback to collectively agree next steps for the industry.



Police Scotland and abnormal loads issue

Scottish Renewables, in collaboration with RenewableUK, facilitated a constructive meeting between Police Scotland, The Scottish Government and stakeholders on March 14. Police Scotland are continuing work to increase resourcing wherever possible, with members reporting some recent increases in capacity and escorts.

SR is scheduling further stakeholder meetings to focus specifically on delays and scheduling with hauliers and OEMs. SR is continuing to work closely with our affected members, RUK and The Scottish Government to liaise with Police Scotland to find solutions to this issue.

Call for Evidence: Proposed amendments to **Supply Chain Plans**

Scottish Renewables has submitted a response to BEIS' call for evidence on proposed amendments to supply chain plans. In our response we argued that a rethink of the SCP process was necessary as the objectives of SCPs do not align with the competitive nature of CfD auctions. We also urged BEIS to adopt a more strategic approach to supply chain development that facilitates greater collaboration between developers, Government and the supply chain itself.

Offshore Coordination - Early Opportunities: Consultation on Ofgem's Minded-to Decision on Anticipatory Investment and Implementation of Policy Changes

Ofgem has published a consultation on anticipatory investments for early opportunity offshore projects. In the consultation Ofgem is proposing to share Anticipatory Investment (AI) risk with consumers and introduce an earlystage assessment process to determine the eligibility of any proposed Al.

Consultation on CMP315 and 375

The ESO published a consultation on CMP315 and 375. Although we don't typically respond to code modifications, this consultation refers to changes to the expansion constant which could have a significant impact on Scottish projects.

Future System Operator - Government and Ofgem's response to consultation

BEIS and Ofgem have published their response to the Future System Operator (FSO) consultation. Government and Ofgem are committing to proceed with the creation of a new, independent FSO, which is expected to be a public corporation. The FSO will have a statutory advisory duty to provide expert advice, analysis and information to Ofgem and government.

This is great news as we advocated in our consultation response for the creation of an independent and public FSO, with enhanced roles and a statutory advisory duty in line with our transition to net-zero.

Isle of Skye decision

Ofgem published its decision on the project's Initial Needs Case and on its suitability for competition. This decision, in which Ofgem acknowledges that there is sufficient evidence of a needs case for the Skye project, reflects the position for which we advocated in our consultation response at the start of this year.

Energy code reform: governance framework

The UK Government published the **Energy code reform**: governance framework. This will give Ofgem new strategic code functions, including the ability to establish and regulate (via licence) one or more code manager(s). This decision will result in an expansion of Ofgem's existing functions.

BEIS has decided not to allow Ofgem to delegate these new functions to third parties or to enable it to redesignate all of its new functions to an alternative organisation without new primary legislation. However, BEIS will be granting the Secretary of State the power to permanently transfer the duty to publish a strategic direction from Ofgem to the FSO, subject to public consultation.

Call for Input: Future of local energy institutions and governance

Ofgem has published a Call for Input on the future of local institutions and governance. This could result in the creation of new independent bodies separate from network companies to oversee local energy systems across the country.

Ofgem believes current arrangements are not geared up to support net-zero at the lowest cost to customers, so new bodies separate from network companies could be created to plan and operate the system locally.

First National Assessment of Potential Heat Network Zones publication

This <u>document</u> was published recently by The Scottish Government and is a computerised analysis of Scotland's heat map and other data sources. The analysis does not include existing heat networks or sources of waste heat or local information.

The analysis identifies 647 potential zones using a lower threshold baseline criteria and 196 potential heat network zones using a more stringent higher threshold criteria. The baseline screening identifies at least one potential heat network zone in every local authority, but with the stringent screening there are six local authorities with no potential zones.
